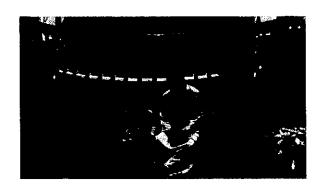
We revitalized our young people's ministries.

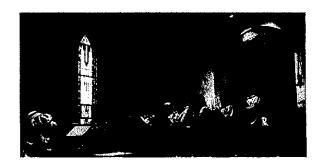
We developed a stronger kids ministry, adding a children's story, a kids group, and a kickoff trip to Seussical at the Frauenthal.

OFFICE ADMINISTRATORS

FOOD PANTRY COORDINATOR

Our Food Pantry is a wonderful mission for our Church and shows our commitment and dedication to our community.

Through heat, sleet, rain and snow while working outside, we have served between 50-95 families each Wednesday from 9:30 to 10:30 am.

We have received numerous monetary and food item donations from the community which has helped immensely.

It takes a lot of time and physical work to do this every week. Tuesdays for packing and average of 90 boxes, distribution on Wednesdays and pick up and unloading food orders at the church about once a month. The orders are often 4,000 to 5,000 pounds.

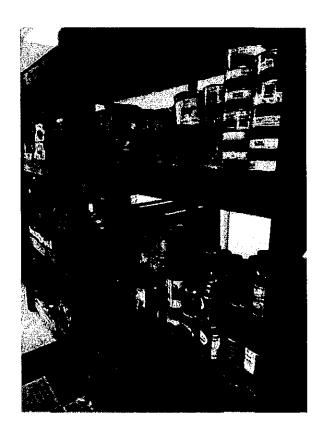

MISSION STATEMENT

The White Lake Area Food Pantry at Lebanon Lutheran Church serves to help a wide variety of hungry people representing the unemployed, the working poor, senior citizens, at-risk children, pregnant teens, and domestic violence victims and more. We offer them a warm breakfast*, fellowship and food and other household items that are donated by members of the community and Feeding America West Michigan Food Bank.

*During the pandemic, our breakfast program as well as in-person shopping has been stopped. The pantry is currently operating at a Drive-Thru only.

The Pantry served 3784 families in 2022, (up from 2884 in '21) or approximately 9208 individuals, (3216 more than '21). The breakdown is as follows: 2610 (776 in '21) children and 4095 senior citizens, (2685 in '21) and 155 Veterans. This makes our pantry almost 45% senior citizen attendees and 28% children.

Over 80% of the food is purchased through Feeding America West Michigan Food Bank, in Comstock Park at a minimal cost of 16 cents per pound. The balance of our food is donated at no cost to us by area businesses, schools and churches. The Pantry welcomes food donations from area food drives, local farmers and summer visitors.

Because the Food Pantry is not a budgeted program of the church, it is entirely dependent upon the generosity of Lebanon Lutheran members, and other churches in the White Lake Community. Community organizations, philanthropic businesses and

individuals are very important to enable the Food Pantry to continue to provide nutritious food for hungry families in our area. We receive a discounted rate for our U Haul rental from Twin Cities. The Food Pantry has received generous grants from Thrivent

Financial, private matching grants, Women's Division of the Chamber of Commerce (Dancing with the Local Stars) and annual food contributions from Quilted Memories, Beacom Chiropractic, HarborLight Credit Union, Edukators, Realtors Who Care, Waterdog Outfitters, as well as numerous anonymous donations.

The pantry served White Lake Families approximately 52 weeks as we did not hold DayCamp in 2022.

We have gone to a Drive-thru only capacity, each Wednesday from 9:30am to 10:30am.

Record keeping is still mandatory and we report our information to Feeding America monthly.

Donations continue to be sanitized prior to entering the church building and we are still utilizing boxes which are generously donated by La Fiesta in Montague. We do get some clients returning the boxes, which we sanitize prior to using them again.

Our pantry is continuing to evaluate the community Covid 19 levels and are able to adapt to different protocols to ensure safety for both our volunteers, staff and clients.

While this method of delivering food to our clients is not the normal we are used to, it allows us to "monitor" the health of our elderly clients somewhat.

Thank you to Pastor Ogden, Sandy Robbins, Kathy Walsh, Sharon Harris, Cindy Lipka, Holly Vanderplaats and Cindy Hendrickson, Tom Palowski, as well as many additional volunteers throughout the year from various groups and schools.

Also, a huge thank you to Denny Mahoney, and Al and Michele Wheeler for their dedicated service in going to New Era and picking up milk weekly from Country Dairy.

CAPITAL CAMPAIGN COMMITTEE

As approved by congregation on September 30, 2018 a Capital Campaign Committee was formed in early 2019. The committee members are Glenn Eaton, Kristine Jordahl, Mike Snell, Pastor Doug Ogden and Curt Crouch.

The Campaign is a four-year process covering the following projects:

2019: Putting a new roof on the sanctuary. Completed \$23,950

2020: Painting the inside of the sanctuary. Completed \$28,500

2021: Painting the lounge and skylight areas with repair to the skylights. Completed \$8,000

2022: Replacing the carpeting throughout the lounge area up to the sanctuary. Completed \$21,567.50

Thank you all for your donations!

A recommendation to use Endowment funds to finish off the carpeting project came to us from a member. That recommendation was

discussed at the finance committee meeting in early 2021 and was moved on to church council and the endowment committee where it was approved. Shortly after the last annual meeting Lebanon's Endowment and Investments took a huge hit in the market. The finance committee recommended to the church council to take a loan from our Food Pantry account instead of using endowment funds. Church Council approved the motion and \$8,764.50 was borrowed from the food pantry account at Shelby State Bank to finish paying for the carpeting project. This loan will be paid back once the completion of the Land Contract sale of the Mears Street house

The committee would like to thank the church council for their guidance, the property committee for their assistance and most of all of you who donated and made these projects possible.

SCRAPBOOK COMMITTEE

ENDOWMENT COMMITTEE

The committee members are Becky Wahr, Jon Blyth, Tony DiNicolo, Sarah Stacy-Schmalz and Terry Beekman.

It has not been a good year for our Endowment Funds performance.

We started this year with a balance of \$90,074 and ended it with a balance of \$60,895 at Fidelity Investments. There was a loss on investments of \$29,179.

The current sub-fund balances are -

General Building Fund – This is a restricted fund in which the gains can be used to maintain, remodel and repair the original Sanctuary built in 1877. The balance in this Sub-Fund as of December 31, 2022 is \$31,211 with \$10,211 available for use.

Outreach Fund – This is a Non-Restricted Fund in which the gains can be used to support our Christian Mission. The balance in this Sub-Fund as of December 31, 2022 is \$30,683 with \$12,263 available for use.

Please consider investing some of your gifting to the Endowment Fund and including it in your estate planning. Further information is available from the Committee Secretary, Tony DiNicolo or myself, including methods of giving, The Mission Statement for use of the Funds and the application forms and the procedure to request a grant from the Fund.

As part of the 150th anniversary year celebration in 2022, Cheri Crouch, Irene Parks, Donna Will, Zoe Fretty, Marie Hendrixon, Frank Hollister, Debbie Wells and Barb Aardema worked on organizing years worth of newspaper clippings and unidentified photos that had been stored at church. We succeeded in copying many clips and inserting them into scrapbooks. We purchased additional scrapbooks and photo albums.

To engage more assistants and participation, we've put unidentified or undated photos in the church lobby so that anyone passing by can help identify the photos. An archival pen is attached to the photo bin, so anyone who can identify people in photos is asked to write the names on the back of the photos, then leave them upside down to dry. (Previously, we used Sticky Notes for identifying people. This way, we save one step by not having to copy the information from the Sticky Notes onto the photos.)

In November, former pastor Larry Foster brought us a shoe box full of photos he had shot during his tenure. He said he had a new camera then, and so recorded many activities—including the construction of the 1990's addition to the building.

Our intention for 2023 is to complete as many scrapbooks, and identify as many photos as possible, then choose what should be included in the permanent archives. We want to display the books in rotation, possibly on the coffee table in the lounge, throughout the year. Barb will seek guidance on what to keep and what to offer to members as keepsakes from genealogy workers at the Torrent House in Muskegon.

We have met several times at 1 p.m. on Fridays, and will announce when that schedule will reconvene. Everyone is welcome to join us! The more eyes we have, the better we can identify people in photos, and/or their connection to Lebanon in newspaper articles.

If you have photos to donate, <u>please indicate</u> the date and names of people pictured—using an archival pen—on the backs of photos. We have an archival pen attached to the photo bin in the lobby, or you can find them at Hobby Lobby or JoAnn Fabrics stores.

It has been another year on this journey of Christian outreach to children. It has been very fulfilling. We continue to keep our sights on the goals we set initially, which are to let them know that:

- 1) God loves them and wants to be their best friend of all
- 2) Lebanon Church cares about them and loves them, too
- Lebanon Church cares about their parents and we are there for the entire family
- 4) Bible stories are really cool

In order to accomplish these goals, we mail out materials to parents and children.

I will mention here that partway through the time I have been working at this, Sue Roesler undertook a calling campaign to contact the parents of the children on our mailing list. Thank you Sue! She couldn't reach all of them, but we were able to ascertain that there were some teenagers who were not interested in church or receiving materials. This was sad but not unexpected, since this age group is a difficult one to engage, even during in-person endeavors. I also have found that

locating mail-only materials for this group is difficult. My goal is to find messages that include our "arrows down" understanding that God meets them with love and acceptance where they are, with no guilt or criticism, and that they are wanted and good enough. These messages need to be heard by adults, but even more so by our tweens and teens today! Sue's calling resulted in a decrease in our numbers, which also decreased our costs somewhat.

The parents of infants and children 0-36 months receive a newsletter monthly called Splash. Children aged 37 months through 5th grade are receiving the Sparks Family Magazine. Please see the descriptions of Splash and the Sparks magazine in the 2021 report as they have not changed.

I appreciate the support the church has given this ministry. It has made it possible to do so much for the children! Please keep the children and this ministry in your prayers.

Lebanon Lutheran Church Annual Meeting January 30, 2022

A hybrid meeting (members in the sanctuary plus members on Zoom, thanks to the technical wizardry of Mike Schmalz) convened at 11:20 a.m. following worship. Council president Meg Eaton presided. Attendees comprised a quorum.

MINUTES

Cheri Crouch made a motion to approve minutes of the January 31, 2021, annual meeting. Wietse Schaafsma supported the motion. Carried.

BALLOT

Meg Eaton announced an addition to the 2022 ballot. Al and Michele Wheeler volunteered to be Synod delegates. There being no further nominations from the floor, and no contested offices, Terry Beekman moved to accept all nominations by acclimation. Scott Keller supported the motion. Carried. Those elected are: Financial Compliance Review Committee, Tony DeNicolo; Ushers, Jim King, John Parks, Terry Beekman; Samaritas Liaisons, Margaret Everling, Donna Stacy; Endowment Committee, Sarah Schmalz; Altar Guild Chair, Michele Wheeler; Church Council (two-year term), Laura Hollister; Synod Assembly Delegates, Al and Michele Wheeler.

FINANCIAL REPORTS

Meg commended Curt and Cheri Crouch, Terry Beekman, and Terri Vanderleest for countless hours spent tracking income and expenses, preparing the budget and paying bills.

Curt noted the following:

- Income was low the first five months of 2021, while we were still worshiping remotely due to the COVID-19 pandemic. After returning to outdoor, in-person worship, the deficit was gradually whittled down, and we covered our \$183,352 budget. Expenses were actually \$176,659, 96.35% of the budget.
- Non-budget income for the food pantry was down a lot in 2021 compared to 2020.
- · A scholarship amounting to \$1,110 under the "ins-and-outs" page was given to worship keyboardist Aeden McCauley.
- · A \$950 gift was given to refugee services via Synod.

On questions from Frank Hollister, Curt explained several changes to the 2021 figures (proposed vs. actual) were due to changes in programming and staff hours during the pandemic. A salary overpayment to Pastor in 2021 is being corrected by a lower salary proposed for 2022. The Federal Government's Paycheck Protective Program also covered some of the staff salaries during the pandemic.

Barb Aardema moved to accept the financial reports. At Wheeler supported the motion. Carried.

2022 BUDGET

Terry Beekman highlighted some sections of the proposed budget;

- · Budgeted expenses are \$196,575, a 7,21% increase over the actual 2021 budget.
- Employees are to receive a 2.5% salary increase.
- · Pastor's salary increases by \$1,395, meeting Synod guidelines.

- Pastor's health insurance continues on Monica's employer's plan for the first six months of 2022, then when Monica retires in June, will continue on her retiree rate with Muskegon County. Lebanon will save \$32,099 on health insurance using the county's plan instead of the synod's plan.
- Council has agreed to use our savings, endowment funds, Thrivent Action cards and Thrivent Choice Dollars for some 2022 programs and anticipated expenses. Major expenses anticipated include a scheduled elevator inspection.

Terry Beekman moved to accept the 2022 budget. Laura Hollister supported the motion. Carried unanimously.

MINISTRY REPORTS

Meg Eaton noted a correction: Council meets the third Tuesday of the month.

Curt Crouch moved to accepted the corrected and as-written reports. Cheri Crouch supported the motion. Carried.

ADJOURNMENT

Cheri Crouch moved to adjourn at 12:02 p.m. Wietse Schaafsma supported the motion. Carried.

We recited the prayer provided in the back of the report, and sang the Doxolgy following adjournment.

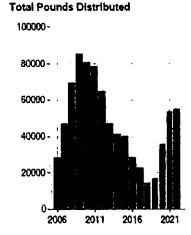

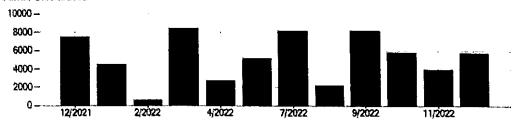

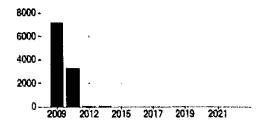


Pounds Distributed by Category (YTD)

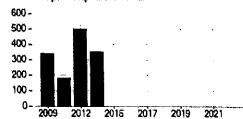

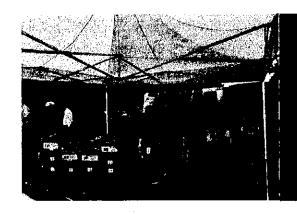

Ince the start of the Ukrainian conflict in late February, Lutheran congregations across the U.S. have come together in creative and collaborative ways to provide relief and support to those fleeing violence a world away. The lave and concern of these congregations have brought together not only their church communities but their larger communities as well.

Reformation Lutheran Church in Media, Pennsylvania, feels especially close to those fleeling the violence in Ukraine. Pennsylvania has one of the highest populations of Ukrainian immigrants in the U.S.

"It feels close to home," said Pastor Alina Gayeuski.

Reformation has a history of abundant response in times of need and the war in Ukraine was no exception. "We asked the congregation to give to Lutheran World Relief to support relief efforts in Ukraine and asked our endowment for a 2-to-1 match for all dollars given to the congregation."

In the end, the match was offered several times from several groups, meaning every dollar donated was multiplied several times.

"We almost joke about our 'Reformation Math," said Pastor Alina of her congregation's generosity, "When we ask for something, we get it tenfold, always. It's beautiful that it's reliable. And yet at the same time, it never ceases to amaze me, Abundance just continues to inspire abundance."

Tom Conroy, Reformation's treasurer and the CEO of the U.S. subsidiary of the Japanese corporation Teikoku, got his company to create an additional match to the endowment's, All in all, Reformation raised nearly \$67,000 for Lutheran World Relief's efforts in Ukraine.

Pastor Alina said her congregation is very mission driven and is constantly looking for ways to serve their neighbors, whether they be down the street or across the globe. Pastor Alina said her congregation is so grateful for organizations like Lutheran World Relief who work on behalf of people in need around the world. "Because of their work, we are able to employ such generosity and affirmations of their humanity in ways that are over and above what we could ever do individually. And that's really great."

We are so grateful for Pastor Alina \dots and for all of you who so passionately steward the gifts of your congregation to make a real difference in the world.

MEET TWO OF THE WOMEN YOUR LOVE IS REACHING



Kristina and her three children were living a peaceful life in Ukraine when the bombing started, and in a matter of moments their world turned completely upside down. After fleeing to a nearby school basement, they found themselves huddled in fear with others from their community and remained there for two weeks. Only sparingly did they dare to leave the basement, dashing home for a quick shower when they felt safe. It was during one of those outings, as bombs flew across the sky and her children ill from the poor living conditions, that Kristina realized she had to get out. As they were boarding the train to depart, the station was bombed, but Kristina miraculously — and barely — still managed to escape to Poland with her children.

Once In Poland, Kristina and her children were welcomed with open arms. Volunteers provided food, drink and warm handshakes to let them know they were not alone. And because of the love of Lutheran congregations, Kristina also received emergency cash funds that will give her the needed money to find an apartment while she looks for a job in a new country. Your love continues to reach refugee families, like Kristina's, by providing ongoing cash transfers and protection services for those who need it most.



When violence broke out in her hometown, Nadia fled with her 2-year-old son Kyrylo to western Ukraine in search of safety. Because of your generosity, they were welcomed with warm meals and a safe place to stay at a Lutheran World Reilef supported center. Together we're helping more than 15,000 of our most vulnerable neighbors in Ukraine by providing temporary housing and essential supplies and equipment, like folding beds, pillows, heaters, personal hygiene items and more. We are also helping the centers prepare for winter by replacing windows.

Because of the love of thousands of Lutheran World Relief quilters and kit-makers, Nadia and Kyrylo also received an LWR Mission Quilt and Personal Care Kit. We've now shipped or distributed nearly \$1 million worth of LWR Quilts and Care Kits in Poland and Ukraine. Please extend our deep gratitude to the quilters and kit-makers in your congregation. Their compassion reminds our neighbors, like Nadia and Kyrylo, of God's loving presence in a world rife with suffering.
